# **REPORT AND NOTIFICATION OF SPILLS AND ACCIDENTAL DISCHARGES TO THE OHIO RIVER AND TRIBUTARIES**

## **PRIVATE CITIZENS:**

IF YOU SEE A SPILL, PLEASE REPORT IT TO ONE OF THE FOLLOWING:

1. The appropriate agency of the state in which the spill occurred
2. The **NATIONAL RESPONSE CENTER (800) 424-8802** (24-hour, toll free)

## **TO THE EXTENT POSSIBLE, THE NOTIFICATION SHOULD CONSIST OF THE FOLLOWING INFORMATION:**

- Date and time of spill event
- Location of spill event
- Proximity to drinking water intake
- Types and quantities of materials spilled
- Velocity of river, relation to spill location and drinking water utility intake
- Contact information for responsible party
- Action taken to stop the occurrence
- Containment and cleanup underway

To minimize the adverse effect that spills and accidental discharges may have on users of water within its jurisdiction, the Ohio River Valley Water Sanitation Commission (ORSANCO) has established the following procedures for assisting in the dissemination of information on spill incidents to water users and control agencies:

**IF THE STATE OR FEDERAL AGENCY IS NOTIFIED FIRST:**

**They shall notify the Commission when a spill or accidental discharge occurs which may affect the water quality of an adjoining or downstream state within the Commission's jurisdiction.**

**IF THE COMMISSION IS NOTIFIED FIRST, THE COMMISSION WILL:**

- Notify the appropriate state agencies
- Notify the appropriate federal agencies
- Notify adjacent and downstream state agencies
- Notify downstream water users

**Reporting to the Commission shall not relieve any municipality, corporation, person, or other entity from responsibility for complying with federal, regional, state, or local statutes.**

**IN ADDITION, THE COMMISSION CAN PROVIDE:**

- Estimates of in-stream concentrations
- Information on time of travel
- Information on river flow and velocity
- List of municipal water users along the Ohio River to agency personnel only

**REPORTING TO THE COMMISSION SHALL NOT RELIEVE ANY MUNICIPALITY, CORPORATION, PERSON, OR OTHER ENTITY FROM RESPONSIBILITY FOR COMPLYING WITH ANY FEDERAL, REGIONAL, STATE, OR LOCAL STATUTES, ORDINANCES OR REGULATIONS WHICH MAY BE APPLICABLE.**

## Spill Notification – Federal Agencies

### U.S. Coast Guard

The U.S. Coast Guard responds to spills on commercially navigable waterways. U.S. Coast Guard Sector Ohio Valley maintains a 24 hour/365 day a year communications watch. A constant listening guard is kept on marine VHF-FM channel 16 (156.8 Mhz), unless conducting Marine Information Broadcasts or working traffic on another channel.

# Ohio River Mile Points and Major Cities




## Ohio River Counties, Drinking Water Intakes, and Locks & Dams

River Miles 0.0-90.0




## Ohio River Counties, Drinking Water Intakes, and Locks & Dams River Miles 90.0-360.0
