## FY 11 Appropriations Help ODS Protect Drinking Water

Thanks to Senators Robert Byrd (D-WV) and Sherrod Brown (D-OH), for securing 3 congressionally sponsored grants totaling \$2.5 million for the Commission's Organics Detection System (ODS). The ODS is a world-class pollution detection system designed to detect chemicals and protect the source of water for more than 5 million Ohio River drinking water consumers. The money will be used to upgrade all ODS analytical and communication equipment to current technology levels. The ODS has been in operation since 1977 and has detected numerous chemicals and compounds that, left undetected, could pose a health risk to consumers.
